APPROVING THE CRITERIA FOR THE BOARD PERIODIC PERFORMANCE EVALUATION CRITERIA

WHEREAS, under the Philippine Coconut Authority (PCA) Manual of Corporate Governance, the PCA Board of Directors has the responsibility to define governance policies and establish the means to ensure that such are followed and periodically reviewed for ongoing improvement. For the Board to effectively carry out this mandate, it has constituted the Governance Committee (GovCom) to assist it in fulfilling its corporate governance responsibilities;

WHEREAS, one of the responsibilities of the GovCom is to oversee the periodic performance evaluation of Board. Accordingly, the GovCom shall adopt an appraisal system for assessing the Board's effectiveness through the <u>Performance Appraisal of the PCA Board of Directors</u>, the briefer of which is hereto attached as **Annex A**;
