## **BOARD RESOLUTION NO. 071-2020**

## APPROVING THE CORPORATE ORDER ON DELEGATION OF APPROVING AND SIGNING AUTHORITIES

WHEREAS, for the purpose of updating, aligning and harmonizing the Corporate Order on Delegation of Approving and Signing Authorities with current laws and issuances, particularly the Government Procurement Reform Act (RA 9184) and its IRR, Management endorsed the proposed Corporate Order on Delegation of Approving and Signing Authorities, as indicated in its Memorandum dated July 23, 2020, referred to herein as Annex "A" and made an integral part of this Resolution;

**WHEREAS**, under the proposed Corporate Order, procurement is decentralized by empowering the Regional Offices to establish its own BAC and BAC Secretariat and to bid and award all items in its Project Procurement Management Plan (PPMP). It aims to expedite processes while at the same time distributing accountabilities, thus, providing check and balance. It also incorporates latest rules on foreign grants, among other important revisions;

**WHEREAS**, the draft Corporate Order was reviewed and deliberated upon by the Programs and Policy Committee during its meeting on August 06, 2020, which endorsed board approval thereof;

NOW, THEREFORE, BE IT RESOLVED THAT, per recommendation of the Board Committee, the proposed Corporate Order on Delegation of Approving and Signing Authorities, referred to hereto as Annex "A" and made an integral part of this Resolution, BE APPROVED, as it is hereby APPROVED.

**RESOLVED FURTHER THAT**, the Administrator is hereby **AUTHORIZED** to sign the said Corporate Order for and in behalf of the Authority.
