5. Bidders are obliged to attend Pre-Bid Conference, and only those who attended are permitted to purchased bid documents.
6. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, or (iii) both on or before **April 10, 2025; 09:30AM**. Late bids shall not be accepted.
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
8. Bid opening shall be on **April 10, 2025; 10:00AM** at the given address below. Bids will be opened in the presence of the bidder or bidders' authorized representative/s.
