

**NEGOTIATED PROCUREMENT FOR TWO FAILED BIDDINGS NO. 01-2024 FOR THE SUPPLY,
TRANSPORT, DELIVERY, AND HANDLING OF VARIOUS INORGANIC FERTILIZER - LOT 2**
(Region IV-MIMAROPA)

KNOW ALL MEN BY THESE PRESENTS:

This AGREEMENT is executed this _____ day of _____ 20_____, by and between:

PHILIPPINE COCONUT AUTHORITY a government-owned and controlled corporation created and existing under P.D. 1468, as amended, with office address at Elliptical Road, Diliman, Quezon City and herein represented by its **Administrator DEXTER R. BUTED** hereinafter referred to as the "**PCA**".

and

YCC Enterprise, OPC, a private company duly registered and existing under the laws of the Republic of the Philippines with business office at NAR Bldg. Purok I, San Isidro, Cabanatuan, Nueva Ecija, represented by **JAYSON JAMES T. DE JESUS**, herein referred to as the "**SUPPLIER**".

WITNESSETH:

WHEREAS, the Entity invited Bids for certain goods, particularly the Supply, Transport, Delivery, and Handling of Various Inorganic Fertilizer – Lot 2 (Region IV (MIMAROPA)), and has accepted a Bid by the Supplier for the supply of those goods in the sum **PESO: TWO MILLION SEVEN HUNDRED THIRTY-THREE THOUSAND NINE HUNDRED PESOS (Php2,733,900.00)** (hereinafter called "the Contract Price").

NOW, THEREFORE, premises considered, the parties hereto have mutually agreed as follows:

1. In this Agreement words and expressions shall have the same meanings as respectively assigned to them in Paragraph 1 (1.1,1-n) of the General Conditions of the Contract.
2. The following documents shall be deemed to form and be read and construed as part of this agreement, viz:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of PESO: TWO MILLION SEVEN HUNDRED THIRTY-THREE THOUSAND NINE HUNDRED PESOS (Php2,733,900.00), YCC Enterprise, OPC agrees to Supply,

Transport, Deliver, and Handle Various Inorganic Fertilizer for Lot 2 (Region IV (MIMAROPA)) in accordance with its Bid.

4. The PHILIPPINE COCONUT AUTHORITY through its **Region IV** office agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


