**FAILURE OF BIDDING - NEGOTIATED PROCUREMENT-TWO FAILED BIDDINGS**

Supply of Petroleum, Oils, and Lubricant for PCA Authorized Government Service Vehicles and Equipment for the Period of May to December 2023

WHEREAS, Purchase Requests (PR) for the Supply of Petroleum, Oils, and Lubricant for PCA Authorized Government Service Vehicles and Equipment for 2023 was prepared, approved and funded;

WHEREAS, CO BAC passed Resolution No. 19, Series of 2023 declaring a 2<sup>nd</sup> Failure of Bidding for the said procurement since no bids were received during the said Opening of Bids and proceed with the Negotiated Procurement for the subject procurement in accordance with Sec. 53 of RA 9184's Revised IRR;

WHEREAS, the CO BAC reposted the said procurement covering the period of May to December 2023 through Negotiated Procurement-Two Failed Biddings;

WHEREAS, on April 24, 2023, the CO BAC conducted the Negotiation for the subject procurement wherein two (2) prospective bidders attended namely, Twinhearts Shell Servicenter and RG Petron;

WHEREAS, on April 27, 2023, the CO BAC conducted the opening of bids for the subject procurement;

WHEREAS, no bids were received during the said Opening of Bids;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the PCA CO BAC, hereby RESOLVE as it is hereby RESOLVED, to declare a Failure of Bidding for Negotiated Procurement-Two Failed Biddings No. 01-2023 more particularly described as the Supply of Petroleum, Oils, and Lubricant for PCA Authorized Government Service Vehicles and Equipment for the Period of May to December 2023 and instructed the End-user/ TWG to conduct a mandatory review for the subject procurement in accordance with RA 9184's Revised IRR.
