Description

- 1. The Philippine Coconut Authority Region XIV- Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), through the Coconut Village Development Project 2022 intends to apply the sum of Two Million One Hundred Thousand Nine Hundred Eighty One and 85/100 (Php 2,100,981.85) being the Approved Budget Contract (ABC) to payments under the contract for Supply, Handling, Transport and Delivery of 11,621 Tissue-cultured Cardava plantlets and 30, 600 Tissue-cultured Lakatan plantlets under Coconut Village Development Project (CVDP) 2022. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Philippine Coconut Authority Region XIV-BARMM now invites bids for the above Procurement Project. Delivery of the Goods is required by 75 days upon the receipt Notice to Proceed (NTP). Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No.

- 4. Prospective Bidders may obtain further information from Philippine Coconut Authority Region XIV- Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) and inspect the Bidding Documents at the address given below during 8:00AM to 5:00PM at the Philippine Coconut Authority XIV-BARMM Regional Office.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on June 9, 2022 from the given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, by facsimile, or through electronic means.
- 6. The Philippine Coconut Authority Region XIV- Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) will hold a Pre-Bid Conference on June 17, 2022, 1:00 PM at the Conference Room of PCA XIV-BARMM, Bangsamoro Coconut Technology Extension Center and Business Hub, Sitio Bubong, Brgy. Kalanganan II, Cotabato City, which shall be open to prospective bidders.

- 7. Bids must be duly received by the BAC Secretariat either through manual submission or online or electronic submission at the office address indicated below, on or before June 28, 2022 at 12:00 PM. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on June 28, 2022 at 1:00PM at the given address below. Bidders who cannot attend physically during the schedule can attend via Online platform (Zoom or Google Meet). Bids will be opened in the presence of the bidders' representative/s (in-person/online) with authorization issued by the company who choose to attend the activity.
- 10. The Philippine Coconut Authority Region XIV- Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
