The Procuring Entity shall allow the bidder to present its proof of payment for the fees *which will be presented in person*.

[NOTE: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB;

provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.]

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *July 12, 2022; 8:30 AM PST*. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on *July 12, 2022; 09:30 AM PST* at the given address below Vensu Bldg. National Highway, General Santos City and/or via Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *Philippine Coconut Authority Region XII* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
