INVITATION TO BID FOR THE SUPPLY, HANDLING, TRANSPORT & DELIVERY OF 100,000 PCS LAGUNA OR AURORA TALL VARIETY COCONUT SEEDNUTS, 100,000 PCS BAYBAY TALL VARIETY COCONUT SEEDNUTS, AND 50,000 PCS OPV DWARF VARIETY SEEDNUTS UNDER THE STRATEGIC PLANTING AND REPLANTING OF CFIDP CY 2023

- 1. The *Philippine Coconut Authority Region I, II, III and CAR*,, through the *Coconut Farmers and Industry Development Plan (CFIDP) CY 2023*, intends to apply the sum of **Four million pesos (Php4,000,000.00) for Lot 1, Four million five hundred thousand pesos (Php4,500,000.00) for Lot 2, and Two million pesos (Php2,000,000.00) for Lot 3, being the ABC to payments under the contract for each lot/***item***. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.**
- 2. The *Philippine Coconut Authority Region I, II, III and CAR* now invites bids for the above Procurement Project. Delivery of the Goods is required by **within 30 calendar days after receipt of Notice to Proceed.** Bidders should have completed, within **a period of five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from Philippine Coconut Authority Region I, II, III and CAR and inspect the Bidding Documents at the address given below during Monday to Friday, 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 27, 2023 to November 20, 2023 from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, Five thousand pesos (PhP5,000.00) for each lot. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

- 6. The *Philippine Coconut Authority Region I, II, III and CAR* will hold a Pre-Bid Conference on **November 06, 2023, 1:30 PM** via face-to-face meeting at Conference Room, 2nd Floor, Guest house building, PCA Compound, Elliptical Road, Diliman, Quezon City and through video conferencing or webcasting via Zoom with meeting credentials in the following page which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through *manual submission* at the office address indicated below on or before **November 20, 2023, 1:00 PM**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on **November 20, 2023, 1:30 PM** at Conference Room, 2nd Floor, Guest house building, PCA Compound, Elliptical Road, Diliman, Quezon City and through video conferencing or webcasting via Zoom with meeting credentials below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
