INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF HAULING TRUCK UNDER CFIDP CY 2023 FUND

- 1. The *Philippine Coconut Authority Region I, II, III and CAR*, through the Coconut Farmers and Industry Development Plan (CFIDP) CY 2023 intends to apply the sum of **Two million five hundred thousand pesos (Php2,500,000.00)** being the ABC to payments under the contract for **Supply and Delivery of Hauling Truck under CFIDP CY 2023 Fund** with **IB NO. 2023-13.** Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *Philippine Coconut Authority Region I, II, III and CAR* now invites bids for the above Procurement Project. Delivery of the Goods is required within **15 regular working days** after receipt of Notice to Proceed. Bidders should have completed, within *a period of five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
- 4. Prospective Bidders may obtain further information from *Philippine Coconut Authority Region I, II, III and CAR* and inspect the Bidding Documents at the address given below during Monday to Friday, 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 20, 2023 to November 08, 2023 from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, Five thousand pesos (PhP5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

The *Philippine Coconut Authority Region I, II, III and CAR* will hold a Pre-Bid Conference on **October 27, 2023, 9:30 AM** via face-to-face meeting at Conference Room, 2nd Floor, Guest house building, PCA Compound, Elliptical Road, Diliman, Quezon City and through video conferencing or webcasting via Zoom with meeting credentials in the following page which shall be open to prospective bidders.

- 7. Bids must be duly received by the BAC Secretariat through *manual submission* at the office address indicated below on or before **November 08, 2023, 9:00 AM**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on **November 08, 2023, 9:30 AM** at Conference Room, 2nd Floor, Guest house building, PCA Compound, Elliptical Road, Diliman, Quezon City and through video conferencing or webcasting via Zoom with meeting credentials below.
