The *Philippine Coconut Authority Regions III and IV-B*, through the *CFIDP HSP CY 2024 Funds* intends to apply the sum of *Five million pesos (PhP5,000,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the Design, *Supply, Delivery, Construction and Installation of Solar-Powered Irrigation System (SPIS) IB No. 2024-12*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.
