WITNESSETH:

WHEREAS, the PCA conducted an advertised public bidding for the Design, Supply, Delivery, Construction and Installation of Solar Powered Irrigation System (SPIS) in Aurora Province Coconut Development Center (APCDC), Dibaraybay, Dinalungan, Aurora under the CFIDP-HSP CY 2024 of the Philippine Coconut Authority;

WHEREAS, in the tender and opening of bids, the offer of Power 4 All Inc. hereinafter referred to as "CONTRACTOR", was evaluated as the Single Calculated and Responsive Bid for subject procurement in the amount of FOUR MILLION FIVE HUNDRED THOUSAND PESOS (PhP 4,500,000.00), herein referred to as "contract price":

WHEREAS, the Design, Supply, Delivery, Construction and Installation of the aforementioned services was awarded to POWER 4 ALL INC. as the single calculated and responsive bid.

NOW THEREFORE, premises considered, the parties hereto have mutually agreed as follows:

- 1. In this agreement words and expressions shall have the same meanings as are respectively assigned to them in Paragraph 1 of the General Conditions of the Contract.

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of Four Million Five Hundred Thousand Pesos (PhP 4,500,000.00), or such other sums as may be ascertained, POWER 4 ALL INC. agrees to provide the Design, Supply, Delivery, Construction and Installation of Solar Powered Irrigation System (SPIS) in Aurora Province Coconut Development Center (APCDC), Dibaraybay, Dinalungan, Aurora in accordance with its Bid.
- 4. The CONTRACTOR shall be fully responsible for the timely delivery of the aforementioned infrastructure project upon acceptance of Notice to Proceed (NTP) at the specified site as stated in the Terms of Reference of the Bidding documents.
- 5. The CONTRACTOR agrees to furnish the PCA all such documents, data and information as may be necessary arising from the delivery and receipts of the services by the PCA or its duly authorized representatives as may be required by PCA, for purposes of monitoring and ensuring deliveries and acceptance have been complied with in accordance with the provision of the terms and conditions of the contract to the satisfaction of all parties and to facilitate the timely payments of the contract price or part thereof due and demandable thereon.
- 6. The PCA hereby covenants to pay the CONTRACTOR the Contract Price or part thereof, or such other sums as may become payable upon faithful compliance with the terms and conditions and in the manner prescribed by this contract agreement.
- 7. If the CONTRACTOR fails to satisfactorily complete the work within the specified contract time in the Terms of Reference, from receipt of Notice to Proceed, inclusive of duly granted time extensions, if any, the CONTRACTOR shall pay the PCA for liquidated damages, and not by way of penalty, an amount equal to at least one-tenth (1/10) of one percent (1%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of this Contract, the PCA shall rescind or terminate the contract, without prejudice to other courses of action and remedies open to it.
