RESOLUTION No. 21, Series of 2022

PUBLIC BIDDING No. 01-2022

WHEREAS, on January 26, 2022, the CO BAC passed Resolution No. 3, Series of 2022 declaring IFE Elevators Philippines, Inc. as the Single Calculated Bidder (SCB) for Public Bidding No. 01-2022 for the Supply, Delivery, Installation, Testing and Commissioning of One (1) Unit Brand New Passenger Elevator and hereby direct the TWG for the subject procurement to undertake bid evaluation and post qualification in accordance with Sections 32 and 34 of RA 9184's Revised IRR;

WHEREAS, the CO BAC passed Resolution No. 5, Series of 2022, declaring IFE Elevators Philippines, Inc. as the Single Calculated and Responsive Bidder (SCRB) for Public Bidding No. 01-2022 for the Supply, Delivery, Installation, Testing and Commissioning of One (1) Unit Brand New Passenger Elevator and recommend to the Head of the Procuring Entity (HOPE) the Award of Contract to IFE Elevators Philippines, Inc. in the amount of Php3,800,000.00 upon approval of APP CY 2022;

WHEREAS, during that time, the PCA APP CY 2022 is still yet to be approved; thus, award of contract cannot be implemented;

WHEREAS, the Board Secretary Certificate for the approved APP CY 2022 was issued on June 15, 2022; thus the award of contract to IFE Elevators Philippines, Inc. was served;

WHEREAS, on June 21, 2022, IFE Elevators Philippines, Inc. responded that they can no longer accept the award of contract since IFE Elevators Philippines was blacklisted due to an order by Light Rail Transit (LRT). IFE Elevators Philippines, Inc. is currently taking legal action on the matter;

WHEREAS, upon validation on the list of blacklisted suppliers/bidders, IFE Elevators Philippines, Inc. was blacklisted on February 18, 2022 to February 17, 2023;

WHEREAS, Sec. 7 - Appendix 17 of RA 9184's Revised IRR on the Uniform Guidelines for Blacklisting of Manufacturers, Suppliers, Distributors, Contractors and Consultant provides that, "xxx But if Blacklisting Order is issued prior to the date of the notice of award ("NOA"), the blacklisted person/entity shall not be qualified for award and such project/contract shall be awarded to another bidder pursuant to R.A. 9184 and its IRR xxx";

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the CO BAC, hereby RESOLVE as it is hereby RESOLVED to declare the following:

- Disqualification of IFE Elevators Philippines, Inc. and termination of bidding process for Public Bidding No. 01-2022 for the Supply, Delivery, Installation, Testing and Commissioning of One (1) Unit Brand New Passenger Elevator;

- Failure of Bidding in accordance with Sec. 35 of RA 9184's IRR; and
- Conduct a Re-bidding for the subject procurement commencing with Re-posting.
