CANCELLATION OF PROCUREMENT ACTIVITIES FOR THE SUPPLY AND DELIVERY OF VARIOUS MEDICINES AND MEDICAL SUPPLIES FOR THE CFIDP-ON-THE-GO MEDICAL AND DENTAL HEALTH MISSIONS FOR COCONUT FARMERS AND THEIR FAMILIES UNDER PB 10-2023

WHEREAS, Purchase Request (PR) for the Supply & Delivery of Various Medicines and Medical Supplies for the CFIDP-on-the-Go Medical & Dental Health Missions for Coconut Farmers and their Families was prepared by the Project Management Office (PMO) was approved and posted accordingly;

WHEREAS, the committee conducted the Opening of Bids for the subject procurement on October 23, 2023 wherein three (3) prospective bidders submitted the bids within the prescribed period of time namely: 1) Byro Pharma Corporation; 2) CGMP Medical Distributors; and 3) Rilem Pharma Corporation;

WHEREAS, on October 26, 2023, the Acting Department Manager of PMO issued a Memorandum cancelling all programs, projects, and activities related to the implementation of the Coconut Farmers and Industry Trust Fund (CFITF) Health and Medical Program particularly the CFIDP-on-the-Go Medical and Dental Health Missions as advised by the Administrator/HoPE;

WHEREAS, as directed under the said Memorandum, all on-going procurement activities under the said program more particularly procurement of medicines and medical supplies under PB No. 10-2023 shall be cancelled effective October 25, 2023;


WHEREAS, during the CO BAC Regular Meeting No. 67, the committee unanimously cancelled the said procurement pursuant to Sec. 41-Reservation Clause of RA 9184's Revised IRR;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the CO BAC, hereby RESOLVE as it is hereby RESOLVED to cancel the procurement for the Supply & Delivery of Various Medicines and Medical Supplies for the CFIDP-on-the-Go Medical and Dental Health Missions for the Coconut Farmers under PB No. 10-2023 pursuant to the above-cited Memorandum and Sec. 41 of RA 9184's Revised IRR.
