Description

1. The Philippine Coconut Authority Region XIV- Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), through the Smallholder Oil Palm Plantation Development Project CY 2022, intends to apply the sum of Seven Million Five Hundred Thirty Four Thousand Seven Hundred Fifty and 77/100 (Php 7,534,750.77.00) being the Approved Budget Contract (ABC) to payments under the contract for Supply, Handling, Transport and Delivery of 25,116 Oil Palm Seedlings under Smallholder Oil Palm Plantation Development Project 2022. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Philippine Coconut Authority Region XIV-BARMM now invites bids for the above Procurement Project. Delivery of the Goods is required by 75 days upon the receipt Notice to Proceed (NTP). Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from Philippine Coconut Authority Region XIV- Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) and inspect the Bidding Documents at the address given below during 8:00AM to 5:00PM at the Philippine Coconut Authority XIV-BARMM Regional Office.

5. A complete set of Bidding Documents may be acquired by interested Bidders on June 8-28, 2022 from the given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 10,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, by facsimile, or through electronic means.

6. The Philippine Coconut Authority Region XIV- Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) will hold a Pre-Bid Conference on June 17, 2022, 9:00AM at the Conference Room of PCA XIV-BARMM, Bangsamoro Coconut Technology Extension Center and Business Hub, Sitio Bubong, Brgy. Kalanganan II, Cotabato City, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat either through manual submission or online or electronic submission at the office address indicated below, on or before June 28, 2022 at 8:30AM. Late bids shall not be accepted.					
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.					
9. Bid opening shall be on June 28, 2022 at 9:00AM at the given address below. Bidders who cannot attend physically during the schedule can attend via Online platform (Zoom or Google Meet). Bids will be opened in the presence of the bidders' representative/s (in-person/online) with authorization issued by the company who choose to attend the activity.
