**A RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PRODUCTION, SUPPLY, HANDLING, TRANSPORT AND DELIVERY OF 55,584 GOOD QUALITY COCONUT SEEDLINGS UNDER SUSTAINABLE PLANTING AND REPLANTING OF LOCAL CULTIVARS PROJECT (SPRLCP) PY 2024 UNDER PUBLIC BIDDING NO. 24-002**

**WHEREAS**, the Philippine Coconut Authority Region V, Legazpi City advertised the Invitation to Bid for the **Production, Supply, Handling, Transport and Delivery of 55,584 Good Quality Coconut Seedlings under Sustainable Planting and Replanting of Local Cultivars Project (SPRLCP) PY 2024** under **Public Bidding No. 24-002** with an **ABC of Three Million Three Hundred Thirty-Five Thousand Forty Pesos (PhP 3,335,040.00)**;

**WHEREAS**, the BAC conducted on February 28, 2024 @ 2:00 PM the opening of bids for the **Production, Supply, Handling, Transport and Delivery of 55,584 Good Quality Coconut Seedlings under Sustainable Planting and Replanting of Local Cultivars Project (SPRLCP) PY 2024** under **Public Bidding No. 24-002** with two (2) bidders participating, namely: CamSur Multi-Purpose Cooperative and Dagooc Farm;

**WHEREAS**, during the opening of the Eligibility & Technical Components of their bids, CamSur Multi-Purpose Cooperative and Dagooc Farm were both declared **INELIGIBLE** due to the following, to wit:

1. CamSur Multi-Purpose Cooperative	<ul style="list-style-type: none"><li>• Submission of patently insufficient Audited Financial Statement particularly absence of required stamped "RECEIVED" by BIR or its duly accredited and authorized institutions in the submitted Audited Financial Statement for the year ending December 31, 2023.</li></ul>
2. Dagooc Farm	<ul style="list-style-type: none"><li>• Submission of patently insufficient Statement of the bidder's Single Largest Completed Contract (SLCC) particularly non-submission of required supporting document/s (End-User's Acceptance or Official Receipt/s or Sales Invoice issued for the Contract).</li></ul>

**WHEREAS**, the authorized representatives of CamSur Multi-Purpose Cooperative and Dagooc Farm were formally notified of their ineligibility through letter-notices dated February 28, 2024 which were emailed and received on the same day; and that the representatives of the bidders were further informed that decisions of the BAC may be questioned by filing a request for reconsideration within three (3) calendar days upon receipt of written notice or upon verbal notification pursuant to Section 55.1 of the 2016 Revised IRR of R.A. 9184;

**WHEREAS**, CamSur Multi-Purpose Cooperative filed a motion for reconsideration dated February 29, 2024 copy of which received by the BAC on March 1, 2024;

**WHEREAS**, after evaluation of the letter-motion of CamSur Multi-Purpose Cooperative, the BAC has found the same without merit and resolved to deny the request for reconsideration through BAC Resolution No. 24-014, Series of 2024;

**WHEREAS**, no motion for reconsideration was received from Dagooc Farm relative to its ineligibility within the prescribed period pursuant to Section 55.1 of the 2016 Revised IRR of R.A. 9184.

**NOW THEREFORE AND BASED ON THE FOREGOING**, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to declare the **FAILURE OF BIDDING** for the **Production, Supply, Handling, Transport and Delivery of 55,584 Good Quality Coconut Seedlings under Sustainable Planting and Replanting of Local Cultivars Project (SPRLCP) PY 2024 under Public Bidding No. 24-002.**

**RESOLVED FURTHER**, to direct the Secretariat to prepare the bidding documents for the second round of bidding for the subject procurement project.
