A RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY, HANDLING, TRANSPORT AND DELIVERY OF AGRICULTURAL GRADE SALT FERTILIZER (AGSF) UNDER CFP FOR CY 2024 (PUBLIC BIDDING NO. 24-001)

WHEREAS, the Philippine Coconut Authority Region V, Legazpi City advertised the Invitation to Bid for the **Supply, Handling, Transport and Delivery of Agricultural Grade Salt Fertilizer (AGSF) under CFP for CY 2024 under Public Bidding No. 24-001** with an **ABC of Five Million One Hundred Sixty-Seven Thousand Six Hundred Seventy-Two Pesos (Php 5,167,672.00)**;

WHEREAS, the BAC conducted on February 28, 2024 @ 9:00 AM the opening of bids for the **Supply, Handling, Transport and Delivery of Agricultural Grade Salt Fertilizer (AGSF) under CFP for CY 2024 under Public Bidding No. 24-001** with AgriGrowth International Corporation as the only bidder who submitted a formal bid/offer for the procurement project;

WHEREAS, during the opening of the bids, AgriGrowth International Corporation was declared as the bidder with Single Calculated Bid (SCB) for Lots 1, 2, 3, 4, 5 & 6 and was formally notified by the BAC on the submission of post-qualification documents pursuant to ITB/BDS Clause 20 of the Philippine Bidding Documents;

WHEREAS, upon careful examination and verification of the documentary requirements submitted by AgriGrowth International Corporation pursuant to the BAC letter dated February 28, 2024 informing of the declaration as bidder with Single Calculated Bid (SCB) for Lots 1, 2, 3, 4, 5 & 6, **no valid Fertilizer and Pesticide Authority (FPA) registration of product** was received from their end within the non-extendible period of five (5) calendar days from receipt of the notice from the BAC;

WHEREAS, Section 34.2 of the 2016 Revised IRR of R.A. 9184 stipulates, among others, that failure to submit any of the post-qualification requirements on time, or a finding against the veracity thereof, shall disqualify the bidder for award;

WHEREAS, the authorized representative of AgriGrowth International Corporation was formally notified of their post-disqualification through a letter-notice dated March 7, 2024 which was emailed and received on the same day; and that the representative of the bidder was further informed that decisions of the BAC may be questioned by filing a request for reconsideration within three (3) calendar days upon receipt of written notice or upon verbal notification pursuant to Section 55.1 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, no motion for reconsideration was received from AgriGrowth International Corporation relative to its post-disqualification within the prescribed period pursuant to Section 55.1 of the 2016 Revised IRR of R.A. 9184.

NOW THEREFORE AND BASED ON THE FOREGOING, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to declare the **FAILURE OF BIDDING** for the **Supply, Handling, Transport and Delivery of Agricultural Grade Salt Fertilizer (AGSF) under CFP for CY 2024 under Public Bidding No. 24-001**.

RESOLVED FURTHER, to direct the Secretariat to prepare the bidding documents for the second round of bidding for the subject procurement project.
