**PUBLIC BIDDING No. 12-2022**

WHEREAS, the PCA, as the Procuring Entity through its Central Office Bids and Awards Committee (CO BAC) posted Public Bidding No. 12-2022 for the Supply & Delivery of Various Motor Vehicles;

WHEREAS, only one (1) prospective bidder bought and submitted the bidding documents for Lot Nos. 1 & 2 namely Toyota Quezon Ave. while two (2) prospective bidders bought and submitted the bidding documents for Lot No. 4 namely Toyota Quezon Ave. and Alpine Motors Corp.;

WHEREAS, on December 28, 2022, the CO BAC conducted the opening of bids for the subject procurement;

WHEREAS, during the said opening of bids, the submitted eligibility/technical documents of both Toyota Quezon Ave. and Alpine Motors Corp. passed the non-discretionary pass-fail evaluation and was declared eligible;

WHEREAS, the submitted financial proposal of the bidders are as follows:

- Toyota Quezon Ave. as the Single Calculated Bidder (SCB) for Lot Nos. 1 & 2;
- Alpine Motors Corp as the Lowest Calculated Bidder for Lot No. 4;
- Direct the TWG for the subject procurement to undertake bid evaluation and post qualification in accordance with Sections 32 and 34 of RA 9184's Revised IRR for Lot Nos. 1, 2, and 4; and
- Declare a Failure of Bidding for Lot No. 3 of the subject procurement since no bids was received for the said lot.
