KNOW ALL MEN BY THESE PRESENTS:

WHEREAS the Entity invited Bids for the SUPPLY AND DELIVERY OF 840 BAGS (50KG) AMMONIUM SULPHATE AND 630 BAGS (50KG) MURIATE OF POTASH UNDER THE CY 2022 SMALLHOLDERS OIL PALM DEVELOPMENT PROJECT and has accepted a Bid by MODEL AGRO SALES - ILOILO for the supply of those goods and services in the sum of THREE MILLION TWO HUNDRED EIGHTY SEVEN THOUSAND FIVE HUNDRED FIFTY PESOS (PHP3,287,550.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - II. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - III. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:
 - IV. Performance Security;
 - V. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - VI. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of THREE MILLION TWO HUNDRED EIGHTY SEVEN THOUSAND FIVE HUNDRED FIFTY PESOS (PHP3,287,550.00), MODEL AGRO SALES ILOILO agrees to supply and deliver 840 bags (50kg) Ammonium Sulphate and 630 bags (50kg) Muriate of Potash to the different pre-determined DOPs in the Province of Bohol in accordance with its Bid.
