**CONTRACT AGREEMENT FOR CONSULTANCY SERVICES FOR THE CONDUCT OF 2021
CUSTOMER SATISFACTION SURVEY**

KNOW ALL MEN BY THESE PRESENTS:

This AGREEMENT executed this _____ day of **JAN 21 2022**, by and between:

PHILIPPINE COCONUT AUTHORITY; a government-owned and controlled corporation created and existing under P.D. 1468, as amended, with office address at Elliptical Road, Diliman, Quezon City and herein represented by its **Administrator BENJAMIN R. MADRIGAL, JR.**, hereinafter referred to as the "**CLIENT**".

and

PEOPLE DYNAMICS, INC., a private company duly registered and existing under the laws of the Republic of the Philippines with business office at U102 OMM-Cintra Building, San Miguel Ave., Ortigas Center, Pasig City represented by **MS. MARIA VICTORIA T. ESTACIO**, herein referred to as the "**CONSULTANT**".

WITNESSETH:

WHEREAS, the PCA seeks to procure the services of a consultancy firm to conduct a customer satisfaction survey for farmers under the programs and projects being implemented and the services rendered by the PCA;

WHEREAS, the PCA conducted an advertised public bidding for the procurement of Consultancy Services for the Conduct of 2021 PCA Customer Satisfaction Survey in accordance with Republic Act (R.A.) No. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations (IRR);

WHEREAS, upon the recommendation of the TWG, the CO BAC resolved in its Resolution No. 47, Series of 2021 to declare People Dynamics, Inc. as the Single Rated Responsive Bidder (SRRB) for the subject procurement and recommend the Award of Contract in the amount of Php755,776.00, which was consequently, approved by the Head of the Procuring Entity;

NOW THEREFORE, premises considered, the parties hereto have mutually agreed as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Terms of Reference
 - (c) Request for Expression of Interest;
 - (d) Instructions to Bidders;
 - (e) Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (*e.g.*, bidder's response to request for clarifications on the bid),



including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (h) Eligibility requirements, documents and/or statements;
- (i) Performance Security;
- (j) Notice of Award of Contract and the Bidder's conforme thereto;

ARTICLE I

CONTRACT DURATION

The contract shall be completed within 10 weeks upon receipt of the Notice to Proceed (NTP) provided herewith that the final draft report shall be submitted by March 2022 or prior to GCG Validation whichever comes first.

The Consultant agrees to furnish the PCA all such documents, data and information as may be necessary arising from the delivery and receipts of the services by the PCA or its duly authorized representatives as may be required by PCA, for purposes of monitoring and ensuring the deliveries and acceptance have been complied with in accordance with the provisions of the terms and conditions of the contract to the satisfaction of all parties and to facilitate the timely payments of the contract price of part thereon due and demandable thereon.

ARTICLE II

CONTRACT AMOUNT

The PCA hereby covenants to pay People Dynamics, Inc. the amount of **SEVEN HUNDRED FIFTY FIVE THOUSAND SEVEN HUDNRED SEVENTY SIX PESOS** (Php755,776.00), inclusive of applicable twelve percent (12%) VAT upon faithful compliance with terms and conditions and in the manner prescribed by this contract agreement.

ARTICLE III

TERMS OF PAYMENT

The CONSULTANT shall be paid in full upon submission to and acceptance by PCA of the Final Report on the 2021 PCA Customer Satisfaction Survey.

No other incidental expenses and reimbursable cost shall be charged to PCA if the intervention/s shall be done thru online or other videoconferencing platforms.

ARTICLE IV

INSTITUTIONAL ARRANGEMENTS

THE CONSULTANT shall report directly to the Head of the PCA Corporate Planning Service (CPS).

ARTICLE V

LIQUIDATED DAMAGES

If THE CONSULTANT fails to satisfactorily deliver any or all of the Goods/services within the delivery period (specified in the Terms of Reference herein attached as Annex "A"), from receipt of the Notice to Proceed, inclusive of duly granted time extensions, if any, the PCA shall, without prejudice to its other remedies under this Agreement and under the applicable law, deduct from the Contract Price, as liquidated damages for every day of delay, at least equal to one-tenth of one percent (0.10%) of the cost of the delivered price of delayed Goods/services or part thereof of delay until actual delivery.
