RECOMMENDING THE AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF WATER SUPPLY SYSTEM FOR PCA-PANGASINAN PROVINCIAL NURSERY

Whereas, the approved budget to purchase the Water Supply System under Small Value Procurement is Sixty-one thousand two hundred pesos (Php 61,200.00);

Whereas, the Regional Bids and Awards Committee (RBAC), posted the Request for Quotation (RFQ) for the above-mentioned project through posting in the Philippine Government Electronic Procurement System (PhilGEPS) on April 20 – May 03, 2022, PCA website on April 20, 2022, and in conspicuous place in the premises of PCA – Regions I, II, III & CAR on May 03, 2022.

Whereas, the first posting of Request for Quotation (RFQ) resulted failure due to no supplier submitted their bids.

Whereas, the Regional Bids and Awards Committee (RBAC), reposted the Request for Quotation (RFQ) for the above-mentioned project through posting in the Philippine Government Electronic Procurement System (PhilGEPS) on May 05 – 10, 2022, PCA website on May 05, 2022, and in conspicuous place in the premises of PCA – Regions I, II, III & CAR on May 04 - 10, 2022.

Whereas, on different dates prior to the deadline of submission of price quotation, quotations from three (3) suppliers were obtained by the Procurement Committee, attested by accomplished Request for Price Quotation (RFQ);

Whereas, based on the preliminary evaluation of bids, the proposal of NORTHERN ASIA SALES CORPORATION found to be compliant with the specifications and the details of the duly accomplished RFQ together with the eligibility requirements;

Whereas, after thorough evaluation of the lowest calculated bidder's capabilities on technical and financial requirements and compliance with the technical specifications set by PCA, using the same procedure prescribed in *Section 34 of Rule X of the IRR of RA 9184*, the proposal submitted by NORTHERN ASIA SALES CORPORATION in the amount of Php 42,100.00 for the procurement and delivery of Water Supply System was found to be within the Approved Budget for the Contract (ABC), and considered by the RBAC as the Single Calculated Responsive Bid;
