

SUPPLY, HANDLING, TRANSPORT, & DELIVERY OF COCONUT SEEDLINGS
LOT 14 under PB 08-2024

(R XIII / Surigao del Norte Mainland)

KNOW ALL MEN BY THESE PRESENTS:

This AGREEMENT is executed this 13 day of AUG 2024, by and between:

PHILIPPINE COCONUT AUTHORITY a government-owned and controlled corporation created and existing under P.D. 1468, as amended, with office address at Elliptical Road, Diliman, Quezon City and herein represented by its **Administrator DEXTER R. BUTED** hereinafter referred to as the "**PCA**".

and

SAN VICENTE COCOSUGAR PRODUCERS ASSOCIATION, INC. (SANVICOPA), INC., a private company duly registered and existing under the laws of the Republic of the Philippines with business office at Sitio Riverside San Vicente, Makilala, Cotabato, represented by **MICHAEL T. CORILLA**, herein referred to as the "**SUPPLIER**".

WITNESSETH:

WHEREAS, the Entity invited Bids for certain goods, particularly the Supply, Handling, Transport & Delivery of Coconut Seedlings- Lot 14 (R XIII / Surigao del Norte Mainland), and has accepted a Bid by the Supplier for the supply of those goods in the sum **THREE MILLION EIGHT HUNDRED FORTY-NINE THOUSAND TWO HUNDRED FORTY-FIVE AND 40/100 PESOS (Php3,849,245.40)** (hereinafter called "the Contract Price").

NOW, THEREFORE, premises considered, the parties hereto have mutually agreed as follows:

1. In this Agreement words and expressions shall have the same meanings as respectively assigned to them in Paragraph 1 (1.1,1-n) of the General Conditions of the Contract.
2. The following documents shall be deemed to form and be read and construed as part of this agreement, viz:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **THREE MILLION EIGHT HUNDRED FORTY-NINE THOUSAND TWO HUNDRED FORTY-FIVE AND 40/100 PESOS (Php3,849,245.40)** or such other sums as may be ascertained, **SAN VICENTE COCOSUGAR PRODUCERS ASSOCIATION, INC. (SANVICOPA, INC.)**

agrees to Supply, Handling, Transport & Delivery of Coconut Seedlings under PB 08-2024 in accordance with his/her/its Bid. through REGION XIII office.

4. The PHILIPPINE COCONUT AUTHORITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding through REGION XIII office.


