## WITNESSETH:

WHEREAS, the Entity invited Bids for certain goods, particularly the Supply, Handling, Transport & Delivery of Coconut Seedlings— Lot 3 (Region XII/ Sultan Kudarat), and has accepted a Bid by the Supplier for the supply of those goods in the sum **THREE MILLION EIGHTY SIX THOUSAND SEVEN HUNDRED FIFTY SEVEN AND 96/100 PESOS (Php3,086,757.96)** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of THREE MILLION EIGHTY SIX THOUSAND SEVEN HUNDRED FIFTY SEVEN AND 96/100 PESOS (Php3,086,757.96), KOOPERATIBA NG MAGSASAKANG PILIPINO NG
