and

SOLIS,** herein referred to as the "**CONTRACTOR**".

WITNESSETH:

WHEREAS, the PCA conducted an advertisement for Public Bidding No. PB 09-2023 for the Repair and Renovation of Comfort Rooms at the PCA Laboratory.

WHEREAS, in the tender and Opening of Bids, the offer of SUN RAYS BUILDERS AND GENERAL SUPPLY hereinafter referred to as "CONTRACTOR" was evaluated as the Single Calculated and Responsive Bid for the subject procurement in the amount of **ONE MILLION TWO HUNDRED SIXTEEN THOUSAND FIVE HUNDRED TWENTY-NINE AND 83/100 PESOS (Php1,216,529.83)** herein referred to as "contract price":

NOW THEREFORE, premises considered, the parties hereto have mutually agreed as follows:

- 1. In this agreement words and expressions shall have the same meanings as respectively assigned to them in Paragraph 1 (1.1,1-n) of the General Conditions of the Contract.
- 2. The following documents shall be deemed to form and be read and construed as part of this agreement, viz:
 - i. Philippine Bidding Documents (PBDs);
 - Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that
