TERMS OF REFERENCE

I. PROJECT AND LOCATION

PROJECT: SUPPLY AND DELIVERY OF PURIFIED WATER FOR THE PERIOD OF MAY

23, 2022 TO DECEMBER 31, 2022

LOCATION: PHILIPPINE COCONUT AUTHORITY, DILIMAN QUEZON CITY

II. SCOPE OF WORK

Weekly delivery of purified water allocated to different offices of the authority.

Specifications:

- 1. Filtration shall be 21 stages
- 2. Weekly delivery of 76 bottles of 5 gals
- 3. The winning supplier shall submit quarterly water testing performed by DOH accredited testing center.
- 4. The winning supplier shall provide 23 units of hot and cold water dispenser
- 5. After sales include the immediate replacement of defective water dispenser and replacement of filter if so warrant
- 6. Water station shall be inspected by the authorized PCA representative.
