1. PROJECT AND LOCATION

To provide 10,000 Serialized RA8048 Chainsaw Registration Sticker with security features (holographic effect).

SCOPE OF WORK

- a. Provide the following serialized stickers with security features
 - i. Width 2.5 inch x length 3 inch (.5 inch in half cut) 10,000 sticker
 - ii. 3m reflective sticker (all weather proof and tampered proof)
 - iii. Holographic seal of PCA logo
 - iv. Pre numbered sticker (reverse print)
 - v. Full colored print with additional security printing
 - vi. With separated special protective shield with security features
 - vii. Place issued, pre-numbered sticker and validity shall be printed in a separated clear sticker with half cut (reverse print)
