

I. PROJECT AND LOCATION

PROJECT: SUPPLY, DELIVERY AND INSTALLATION OF TWO (2) UNIT 3TR FLOOR MOUNTED AIRCONDITIONER, INVERTER TYPE

LOCATION: Ground floor, PCA R&D Bldg. Elliptical Road, Quezon City

- 1. Fabrication of steel brackets and base for indoor and outdoor unit.
- 2. Installation of AC unit based on standard workmanship and using quality materials; i.e. copper tube, drain pipe, Freon, etc.
