## I. PROJECT AND LOCATION

**PROJECT:** SUPPLY, DELIVERY AND INSTALLATION OF ONE (1) UNIT 4HP FLOOR MOUNTED AIRCONDITIONER, INVERTER TYPE

LOCATION: 7th floor, PCA R&D Bldg. Elliptical Road, Quezon City

#### II. SCOPE OF WORK

- 1. Fabrication of steel brackets and base for indoor and outdoor unit.
- 2. Installation of AC unit based on standard workmanship and using quality materials; i.e. copper tube, drain pipe, Freon, etc.
- 3. Testing and commissioning.
