## **TERMS OF REFERENCE**

Supply and Delivery of Medicines for the Conduct of the CFIDP-On-The-Go Medical and Dental Health Mission

#### A. BIDDING / DOCUMENTARY REQUIREMENTS

- 1. Notarized certification that the bidder is a pharmaceutical company that has been in existence in the Philippines for the past five (5) years;
- 2. If the bidder is not the manufacturer, certification from the pharmaceutical company that the bidder is an exclusive and/or authorized distributor that has been in existence in the Philippines for the past five (5) years;
- 3. The bidder shall submit any of the following (whichever is applicable):
  - Notarized certification from the pharmaceutical company who developed and manufactured the original drug, stating that said pharmaceutical company is the original owner of the patent or the innovator of the product; OR
  - b. For medicines where the pharmaceutical company is NOT the one who developed and manufactured the original drug: a valid drug assay, which testing/evaluation was conducted within the last two (2) years reckoned from the date of bidding, and conducted by any of the following recognized testing laboratories:
    - i. Center for Drug Research, Evaluation and Studies, Inc. (CEDRES);
    - ii. University of the Philippines Philippine General Hospital (UP-PGH);
    - iii. Sentro ng Pagsusuri, Pagsasanay at Pangangasiwang Pang-Agham at Teknolohiya Corp. (SENTROTEK); and
    - iv. ADIP Testing and Research Laboratory, Inc.
- 4. Certificate of Product Registration issued by the Food and Drug Administration (FDA) for the product;
- Certificate of Good Manufacturing Practice issued by the FDA;
- 6. Batch Release Certificate issued by the FDA;
- 7. License to Operate issued by the FDA with List of Sources (whether the bidder is a manufacturer, importer, seller or distributor);
- 8. Certification by the Medical Officer that medicines and drugs requisitioned are included in the Philippine National Drug Formulary (PNDF) Current Edition;

- 9. Delivery Receipt / Invoice bearing the Lot Numbers and Expiry Dates of the drugs and medicines;
- 10. Guarantee letter stating that the bidder shall replace the following, if awarded the contract:
  - a. Unused stocks at least three (3) months prior to the date of expiration; and
  - b. Damaged/defective stocks.

The Guarantee Letter to be submitted by the bidder shall not contain any validity period.

#### **B. TERMS AND CONDITIONS**

1. Medicines to be Procured for the Conduct of the Medical and Dental Health Mission: The Philippine Coconut Authority (PCA) Region IX, will procure various medicines for the conduct of a medical and dental health mission in Region IX as part of PCA's implementation of its Health and Medical Program for Coconut Farmers and Their Families under Republic Act No. 11524, otherwise known as the Coconut Farmers and Industry Trust Fund (CFITF) Act of 2021 and the Coconut Farmers and Industry Development Plan (CFIDP) approved through Executive Order No. 172 Series of 2022.

The amount of **Nine Hundred Seventeen Thousand Seven Hundred Fifty Two Pesos** (**Php 917,752.00**) was the Approved Budget for the Contract (ABC). The detailed list and quantity of the medicines are specified in **Annex A**.

- 2. **Medicine Viability**: Medicines to be delivered must have expiry dates as follows:
  - At least one (1) year from the date of delivery of medicines with a shelf life of three (3) years or less;
  - b. At least two (2) years from the date of delivery for medicines with a shelf life of more than three (3) years.
- Quality of Medicines: For delivery of medicines other than the innovator drug, the
  medicines to be delivered should be the same batch/lot number as indicated in the drug
  assay certificate submitted during the bidding/procurement process conducted by any of
  the abovementioned testing laboratories.

In case the medicines to be delivered is of a different batch/lot number, the delivery must be accompanied by a valid drug assay certificate pertaining to batch/lot of medicines being delivered, preferably conducted by any of the abovementioned testing laboratories. Presentation of valid drug assay shall be applicable to all deliveries, including replacement stocks for near-expiring medicines.

### 4. Pull-out and Replacement of Near-Expiring Medicine:

- a. <u>Pull-out</u>: The awardee/supplier shall pull-out near expiring unused stocks at least three (3) months prior to the date of expiration of medicines.
- b. Replacement: The awardee/supplier shall replace the pulled-out stocks with fresh stocks, i.e. replacement stocks shall have an expiration date of at least one (1) year from date of its delivery. Replacement stocks shall be delivered within seven (7) days reckoned from the date of the pull-out of near-expiring medicines.
- 5. **Delivery Period:** The awardee/supplier shall deliver the medicines within seven (7) calendar days from receipt of Notice to Proceed (NTP) or Notice to Deliver (NTD) to be issued by PCA Region IX.

The medicines shall be delivered to PCA Region IX or to any of its provincial offices if so required by PCA Region IX ensuring for the purpose that actual delivery shall take place not less than seven (7) days before the scheduled medical and dental health mission which will be conducted by PCA Region IX.

6. Schedule of Medical and Dental Health Mission: As mentioned the awardee/supplier shall deliver the medicines to PCA Region IX or to any of its provincial offices if so required by PCA Region IX not less than seven (7) days before the scheduled medical and dental health mission after said awardee/supplier receives a Notice to Proceed (NTP) or Notice to Deliver (NTD) to be issued by the PCA Region IX.

For reference purposes, attached as **Annex B**, the schedule of medical and dental health mission which will be conducted by PCA Region IX. The said schedule is subject to change by both PCA Central Office and PCA Region IX and may extend after year 2023. Also indicated are the details of contact persons and addresses of PCA Region IX and its provincial offices where the medicines shall be delivered by the awardee/supplier.

- 7. **Medicines to be Delivered for the Medical and Dental Health Mission**: There are two (2) sets of medicines which the awardee/supplier shall deliver for the medical and dental health mission. These are:
  - a. <u>Medicines for the Dental Group</u>: The medicines shall be properly packaged and marked "Medicines for the Dental Group" separate from the other set of medicines ensuring that the medical items and container used to package these items will not be prone to damage in cases when there is a need to transport them by the end-user under heavy rain; and
  - b. Medicines for the Medical Group: The medicines shall be properly packaged and marked "Medicines for the Medical Group" separate from the other set of medicines ensuring that the medical items and container used to package these items will not be prone to damage in cases when there is a need to transport them by the end-user under heavy rain.

8. Payment Terms: The delivered medicines shall be immediately inspected on the same day it was delivered by the PCA Regional Inspectorate Group, together with a representative from the Commission on Audit (COA) and other concerned parties as may be deemed necessary to check compliance with the TOR prior to acceptance.

Payments shall be computed based on the actual quantity of medicines inspected and accepted by PCA Region IX. Each payment shall be processed upon receipt of the sales invoice and other supporting documents necessary to facilitate the processing of payment.

9. Liquidated Damages: In case of delayed delivery of supplies and service(s), the PCA may upon its discretion, extend the delivery period, subject, however, to the imposition of appropriate liquidated damages, the amount of which shall be at least equal to one-tenth of one percent (0.001) of the cost of the unperformed portion for very day of delay, collectible from any money due or maybe due to the supplier/contractor, whichever is convenient to PCA. Once the cumulative amount of liquidated damages reached ten percent (10%) of the amount of the contract, the PCA may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it. If the supplier, however fail to effect complete delivery within the extended period, the PCA shall have the right to cancel said contract, and shall constitute a ground for the supplier to be disqualified from future biddings, without prejudice to the imposition of other sanctions provided for under Republic Act No. 9184 and its 2016 Implementing Rules and Regulations (IRR).
