Once the cumulative amount of the liquidated damage reaches ten percent (10%) of the contract price, the procuring entity shall rescind the contract without prejudice to other courses of action and remedies open to it.

The PCA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in accordance with Section 41 or RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.

1. Outer Bag

- Fabric and Construction-woven fabric polypropylene
 - 12 X 12 mesh, 850 denier
- Size
 - 535mm X 865mm
- Capacity
 - 40 kilos

Double top stitching shall be minimum of one (1) inch from the selvedge and not to include the inner liner.

2. Inner Bag

- Polyethylene, .0013 mm and sealed mechanically after exhausting the air at the top and film Heat at the bottom
