REGIONAL BIDS AND AWARDS COMMITTEE

RESOLUTION TO DECLARE A FAILURE OF BIDDING RE: SUPPLY AND DELIVERY OF 43,489 (50-KG) BAGS OF MULTI-NUTRIENT FERTILIZERS (MNF) FOR THE YOLANDA REHABILITATION AND RECOVERY PROGRAM (YRRP) COCONUT FERTILIZATION PROJECT (CFP)

Resolution No: 2020 - 0097

WHEREAS, the Committee conducted the scheduled opening of bids for the procurement of 43,489 bags of MNF under the YRRP-CFP on November 5, 2019;

WHEREAS, there were two (2) bidders who submitted their bids, namely DRREF Agri Products Marketing (DRREF) and Modern Time Enterprises, Incorporated (MTEI);

WHEREAS, under the non-discretionary "pass/fail" criteria, DRREF was declared ineligible and MTEI was declared as having the Lowest Calculated Bid. The Notice of Lowest Calculated Bid was sent to MTEI on November 8, 2019 which also contained information on the schedule of the post qualification visit and post qualification requirements that needs to be complied;

WHEREAS, DRREF submitted a Motion for Reconsideration dated November 8, 2019 for the Committee to reconsider the deficiencies noted in the documents submitted during the opening of bids. However, the RBAC denied the motion filed by DRREF in its DECISION dated November 14, 2019.

WHEREAS, upon post-qualification evaluation conducted on November 18, 2019, however, MODERN TIME ENTERPRISES, INC. was not able to meet the required Technical Specifications, specifically on the deficiencies noted in the sack sample, per Technical Working Group (TWG) report and recommendation;

WHEREAS, on November 25, 2019, the RBAC adopted the post qualification report submitted by the post qua team thru Resolution No. 2019-0096 not to recommend the award of contract to MTEI on the ground that it failed to submit the compliant version of the sample sack being one of the requirements for post qualification.

WHEREAS, MTEI filed a Motion for Reconsideration dated December 5, 2019 addressed to the Office of the Administrator (and was remanded to PCA Region VII for action of the BAC per Memo 1219.604 dated December 12, 2019). The BAC denied the motion filed per Committee Decision dated December 20, 2019.

WHEREAS, the RBAC was furnished and received a copy of the appeal of Modern Time Enterprises, Incorporated (MTEI) addressed to President Rodrigo R. Duterte for presidential intervention on the decision of the Bids and Awards Committee of PCA Region VII on the Motion for Reconsideration (MR) filed by their company. The BAC could no longer act on the appeal because there was no formal protest from MTEI that has been filed with the Head of Procuring Entity. Nevertheless, the RBAC prepared its comments in response to said appeal should PCA Central Office would require us to submit said document.


