RESOLUTION TO CANCEL THE BIDDING RE: TRANSPORT AND DELIVERY OF 43,489 BAGS MULTI-NUTRIENT FERTILIZERS FROM DISPORT TO DIFFERENT BARANGAYS IN NORTHERN CEBU UNDER THE YOLANDA REHABILITATION AND RECOVERY PROGRAM COCONUT FERTILIZATION PROJECT

WHEREAS, the Committee conducted the scheduled opening of bids on December 2, 2019 for the procurement of Transport and Delivery of 43,489 Multi-Nutrient Fertilizers from Disport to Different Barangays in Northern Cebu under the Yolanda Rehabilitation and Recovery Program Coconut Fertilization Project;

WHEREAS, there were Two (2) bidders who submitted their proposals, namely, KAMIKO CARGO MOVERS CORPORATION and QUICKWAY CUSTOMS BROKERAGE FIRM of which the latter was declared as the lowest calculated bidder subject for post qualification;

WHEREAS, QUICKWAY CUSTOMS BROKERAGE FIRM has completely submitted the post qualification requirements, however, the Committee was not able to continue the process in view of the following reasons:

- Declaration of a failure of bidding on the procurement of 43,489 bags of MNF under the YRRP Coconut Fertilization Project;
- Declaration of State of National Health Emergency;
- Information from PCA Central Office on the proposed move to realign unexpended program funds for COVID Response Projects;
- · Difficulty of the BAC to convene;

WHEREAS, the Bid Securing Declaration submitted by QUICKWAY CUSTOMS BROKERAGE FIRM had already expired last June 8, 2020, even discounting the days when the City of Mandaue was under the Enhanced Community Quarantine from March 27, 2020 to June 2, 2020 as provided for under the Bayanihan to Heal as One Act;

NOW THEREFORE, in view of the foregoing circumstances, the RBAC has resolved to CANCEL THE BIDDING ON THE PROCUREMENT OF TRANSPORT AND DELIVERY OF 43, 489 BAGS MNF FROM DISPORT TO DIFFERENT BARANGAYS OF NORTHERN CEBU.
