**A RESOLUTION ENDORSING THE SUBMITTED COCONUT FARMERS AND INDUSTRY DEVELOPMENT PLAN (CFIDP) OF THE PHILIPPINE COCONUT AUTHORITY (PCA) TO HIS EXCELLENCY PRESIDENT RODRIGO ROA DUTERTE AND REQUESTING TO EXPEDITE ACTION, APPROVAL AND RELEASE OF THE SAME SO THE COCONUT FARMERS CAN AVAIL OF THE BENEFITS ON A SOONEST POSSIBLE TIME.**

**Whereas,** The Republic Act 11524 otherwise known as the Coconut Farmers and Industry Trust Fund Act aims to consolidate the benefits due to the poor and marginalized coconut farmers to attain increased incomes for coconut farmers, alleviate poverty, and achieve social equality.

**Whereas,** the CFIDP aims to increase income of coconut farmers, alleviate poverty, education and social equity, and rehabilitation and modernization of the coconut industry towards farm productivity;

**WHEREAS,** the COVID pandemic and the increase in the fuel prices are adversely affecting the livelihood of the coconut farmers;

**WHEREAS,** the release of the coconut levy fund is one of the best options which can readily address the sustenance of the coconut farmers and the development of the coconut industry as a whole;

**WHEREAS,** Philippine Coconut Authority, being mandated to promote the rapid integrated development and growth of the coconut and other palm oil industry in all its aspects will ensure that the coconut farmers become direct participants in, and beneficiaries of such development and growth;

**WHEREAS,** the coconut farmers can undertake cooperative efforts towards development of self-sustaining and self-directing community of small coconut farmers, tenants, farm workers, in collaboration with the LGU and other stakeholders for the purpose of developing skill, promoting productivity, and increase of farm income through group marketing, village level processing and/or coco- by product utilization and group procurement of inputs.

**WHEREFORE,** on motion of Director Santos Lanzon Jr., and unanimously seconded by the majority, be it;

**RESOLVE, AS IT IS HEREBY RESOLVED,** to request His excellency President Rodrigo Roa Duterte to expedite action, approval and release of the **COCONUT FARMERS AND INDUSTRY DEVELOPMENT PLAN (CFIDP)** submitted by the **PHILIPPINE COCONUT AUTHORITY (PCA)** so the coconut farmers can avail of the benefits on a soonest possible time.


